

What is Extracurricular Tax Credit?

A tax credit is a dollar for dollar reduction in the actual tax owed. For example, if you owe \$400.00 in state income taxes and you donate \$200.00 to a public school for extracurricular activities, you may subtract the \$200.00 from your tax bill and pay the state just \$200.00. The added benefit is that your donation will go towards the program of your choice!

How will my donation be used?

These dollars can go to activities for band, uniforms, admission to events, travel to various band events, etc.

How much can I give?

For a single individual or head of household, the tax credit is \$200. Individuals filing married or jointly, the tax credit is \$400.00. You may split your \$400.00 donation among more than one public school, but will still qualify for a maximum state credit of \$400.00.

Do I have to donate the full amount?

Absolutely not! Any amount you can donate can be used as a credit against your tax liability, and will be greatly appreciated as well! Arizona tax laws (ARS 43-1089.01) allows taxpayers a tax credit of up to \$200 if you are single or \$400 per married couple. For example, if you donate \$50, your state tax credit would be \$50.00.
